Agreement

The following agreement represents an agreement between Crescent Moon Childbirth Services (lessor) and the lessee.

1. I do hereby acknowledge and agree that said lessor would lease the TENs identified in this rental contract to me, the lessee.
2. Lessee understands that the rental price, \$60 for the tens package, is on a per birth basis of a period of approximately 5 weeks with delivery flexibility due to other birthing families. Extensions available as available for \$15 per week.
3. Lessee agrees to pay lessor \$15 each way for pickup and handling charges, if applicable. I understand that delivery is free of charge.
4. Lessee acknowledges that this agreement is non-transferrable.
5. I understand the following safety issues; must not be used before 37 weeks of pregnancy , must not be used in water, must not be used by anyone fitted with a cardiac pacemaker. If you suffer from epilepsy or have any concerns whatsoever, consult your medical advisor.
6. Lessee agrees to take full responsibility for the manner in and purpose for which said TENs is used. The success of the TENS in labour is neither guaranteed nor warranted.
7. Lessee agrees to contact lessor within five days of baby's birth to arrange TENs return.
8. Lessee agrees to return the TENs to lessor undamaged following its use. Lessee agrees to deliver the rented TENs within ten days of birth or lessee will be charged an additional \$15 per week.
9. Lessee agrees to pay full retail price for the replacement or repair of rented TENs in the event that it is damaged, not returned to lessor, or rendered unusable while in lessee's possession. This fee will be charged to the lessee's credit card.
10. Lessee understands that there will be no reduction in the rental fees if the TENs is unused during the rental period, if the TENs is returned before the birth or before the end of the rental period.
11. Lessee understands that the rental fee is nonrefundable, and that no portion of the rental fee will be refunded.
12. Lessee agrees to release and hold harmless lessor and/or any agent thereof, its members, employees, associates, and affiliated manufacturers from any and all responsibility or liability for maternal complications, infant mortality or morbidity, or injury to any or all persons in connection with the use of rented TENs that may occur before, during, and/or after labor and/or birth in the TENs provided by the lessee.
13. Lessee specifically holds lessor harmless from any claims made by third parties, as well as any damage or injury to property occasioned by the use of the TENs during the rental period or while the TENs is otherwise in the possession of the lessee, and further more agrees to indemnify lessor for any and all liability or expenses including attorney fees, incurred by lesser occasioned by the use of the TENs during the rental period or while the TENs is otherwise in possession of the lessee.
14. Cancellation for TENs will be refunded less a \$20 processing fee ONLY if cancellation is received six weeks prior to lessee's due date.
15. Lessee understands the cancellation policy and refund policy.
16. In the event that the baby arrives before the TENs machine is delivered, lessee will be refunded less a \$20 processing fee.
